Section 1; Health Guarantee

The customer has a health guarantee extending to the close of the fifth (5) business day after the date of purchase, in which to have the kitten checked by a licensed veterinarian and is urged to do so. If the veterinarian finds anything seriously wrong with the kitten, the kitten will be exchanged for another kitten of equal value or the purchase price refunded, provided a letter from the examining veterinarian is offered as evidence of the kittens illness, <u>and</u> the kitten is returned within the guaranteed period. No exchange or refund will be made after this period.

Section 2; Papers/Pedigree Requirement

Unless this kitten is sold as a breeder, papers/pedigree will not be handed out at this time of purchase. Anyone purchasing a kitten sold as a pet <u>MUST</u> have the kitten altered between six and eight months of age by a licensed veterinarian and a certificate of altering <u>MUST</u> be mailed to and received by the breeder before the kitten is nine calendar months old. After the certificate of altering is received by the breeder, the kitten's registration papers will be sent to the purchaser. A certificate of altering is required even if the purchaser does not desire the registration papers. <u>Under no circumstances will this section be ignored!!!</u>

Section 3; Conditions of Sale (page 2 of 2)

- 1) This cat/kitten may not be resold, co-owned, leased, traded, exchanged, housed or given away without receiving written permission of the breeder aforementioned. If for any reason a good home cannot or will not be provided, the cat/kitten will be returned to the breeder, without refund.
- 2) Adequate indoor sanitary facilities will be provided and this cat/kitten will not be allowed to roam outdoors.
- 3) Under no circumstances will this cat/kitten have all four paws declawed. Front declaw is fine, however I recommend not being lazy and keeping their claws trimmed.
- 4) The aforementioned breeder shall not be responsible for any food, health care expenses, boarding or transportation of this cat/kitten after this contract is signed and dated.
- 5) The purchaser promises to feed a premium quality cat food with meat as the main ingredient. I recommend Innova for a quality dry food.
- 6) Purchaser of said cat/kitten, can expect to receive follow-up phone call to ensure compliance of this contract. If the breeder finds the purchaser to be in violation of this contract, its terms and conditions, he/she shall be assessed a fee of \$500.00 per term violation to the breeder as a penalty for violating this contract. All legal proceedings shall be held in the county/state where the breeder lives (Sterling Heights, MI) in accordance with the rulings and regulations.
